**APPLICATION FOR PROBATE OF WILL  
AND ISSUANCE OF LETTERS TESTAMENTARY**

To the Honorable Judge of the Court:

**Julia Ann Conley, Applicant,** furnishes the following information to the Court for the probate of the written Will of **Robert Jack Conley aka Bobby Ed Conley, Decedent,** and for issuance of *Letters Testamentary*:

1. Applicant is an individual interested in this estate, domiciled in and residing at 321 CR 3330, P.O. Box 54, Clifton, Bosque County, Texas 76634. The last three digits of Applicant's Social Security and Texas driver's license numbers are 140 and 962, respectively.

2. Decedent died on July 12, 2023, at his home at 321 CR 3330, Clifton, Bosque County, Texas 76634, at the age of 91 years. The last three digits of Decedent's Social Security number and identification card numbers are 029 and 862, respectively.

3. This Court has jurisdiction and venue because Decedent resided in this county at the time of death and Decedent owned property interests in this county.

4. Decedent owned real and personal property described generally as homestead and other real estate in Bosque County, Texas, stocks, note receivable, bank accounts, a vehicle, household goods and personal effects of a probable value of less than \$2,000,000.00.

5. Decedent left a valid, written Will dated February 5, 2020, *the Will*, which was never revoked and is filed in this cause.

6. The subscribing witnesses to the Will were Signi Knudson, who at the time of the Will's execution resided near Meridian, Bosque County, Texas & Kati Yant, who, at the time of the Will's execution resided near Iredell, Bosque County, Texas. The Will was self-proved in the manner prescribed by law.

7. Decedent was married two times. Decedent's first marriage was to Patsy King, which ended in divorce in about the 1970s in Bosque County, Texas. Of this marriage, only four children were born:

**Serena Lynn Conley**, now an adult, residing at 1718 CR 4145, Cranfills Gap, Bosque County, Texas 76637;

**Billy Wayne Conley**, now an adult, residing at 2501 Featherstone Ct., Arlington, Tarrant County, Texas 76001;

**Bobby Ed Conley aka Bobby Ed Graham**, now an adult, residing at 2098 Jasper Hollow Rd., Haworth, McCurtain County, Oklahoma 74740; and

**Ruth Arlene Jameson**, Deceased on May 14, 2021.

Decedent's second and final marriage was to Julia Ann Conley and is Decedent's surviving spouse. No children were born of this marriage.

No other child was ever born to Decedent, adopted by Decedent, or taken into Decedent's home with the understanding of adoption.

None of Decedent's marriages were dissolved after the date of the Will.

8. A necessity exists for administration of this estate.

9. Neither Texas, nor any governmental agency of Texas, nor any charitable organization is named in the Will as a devisee. The Will's beneficiaries are Julia Ann Conley, residing at 321 CR 3330, Clifton, Bosque County, Texas 76634; Serena Lynn

Conley, residing at 1718 CR 4145, Cranfills Gap, Bosque County, Texas 76637; Billy Wayne Conley, residing at 2501 Featherstone Ct., Arlington, Tarrant County, Texas 76001; Bobby Ed Conley aka Bobby Ed Graham, residing at 2098 Jasper Hollow Rd., Haworth, McCurtain County, Oklahoma 74740; Leah A. Anderson, residing at 341 CR 3330, Clifton, Bosque County, Texas 76634; Paul B. Putman, residing at 4137 Hwy 6, Clifton, Bosque County, Texas 76634; Haleigh Jameson, residing at 116 Price Cir., Frisco, Denton County, Texas 75036; Abageal Jameson, residing at 6601 W Plano Pkwy Apt #1314, Plano, Collin County, Texas 75093; and Collin Jameson, residing at 7516 Shasta Dr., McKinney, Collin County, Texas 75071.

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.

11. Decedent's Will named Applicant to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting *Letters Testamentary*, and Applicant would be entitled to such Letters.

12. Decedent's Will (Section VIII) grants the Independent Executor full power and authority over Decedent's assets, including the power to sell, manage and dispose of Decedent's property.

13. Pursuant to *Texas Estates Code Section 256.052(b)*, no information required for this Application has been omitted.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that *Letters Testamentary* be issued to Applicant; and that all other orders be entered as the Court may deem proper.
