**APPLICATION FOR PROBATE OF WILL
AND ISSUANCE OF LETTERS TESTAMENTARY**

To the Honorable Judge of the Court:

Brenda Charlene Kirkland Freeman, *Applicant*, furnishes the following information to the Court for the probate of the written Will of **Eugene Wendell Freeman**, *Decedent*, and for issuance of *Letters Testamentary*:

1. Applicant is an individual interested in this estate, domiciled in and residing at 171 CR 1518, Morgan, Bosque County, Texas 76671. The last three digits of Applicant's Social Security and Texas driver's license numbers are 839 and 790, respectively.

2. Decedent died on June 20, 2023, at Providence Health Center in Waco, McLennan County, Texas 76712, at the age of 70 years. The last three digits of Decedent's Social Security number and driver's license numbers are 588 and 098, respectively.

3. This Court has jurisdiction and venue because Decedent resided in this county at the time of death and Decedent owned property interests in this county.

4. Decedent owned real and personal property described generally as homestead and other real estate in Bosque County and Hill County, Texas, bank accounts, vehicles, household goods and personal effects of a probable value of less than \$500,000.

5. Decedent left a valid, written Will dated October 6, 2014, *the Will*, which was never revoked and is filed in this cause.

6. The subscribing witnesses to the Will were Lisa Silas, who, at the time of the Will's execution, resided near Whitney, Hill County, Texas & Angela Powers, who, at the

time of the Will's execution, resided near Whitney, Hill County, Texas. The Will was self-proved in the manner prescribed by law.

7. Decedent was married three times. Decedent's first marriage was to Glenna Freeman, which ended in divorce in about the year 1999 in Bosque County, Texas. Of this marriage one child was adopted:

Kristie Ann Freeman, now an adult, residing at 506 FM 2604,
Whitney, Hill County, Texas 76689.

Decedent's second marriage was to Linda Freeman, which ended in divorce in July of 2007 in Hill County, Texas. No children were born of this marriage.

Decedent's third and final marriage was to Brenda Charlene Kirkland Freeman, Decedent's surviving spouse. No children were born of this marriage.

One other child was born to Decedent, that was placed for adoption, Dawn Lee Freeman, and is not considered an heir-at-law according to Decedent's Will.

None of Decedent's marriages were dissolved after the date of the Will.

8. A necessity exists for administration of this estate.

9. Neither Texas, nor any governmental agency of Texas, nor any charitable organization is named in the Will as a devisee. The Will's beneficiaries are Kristie Ann Freeman, residing at 506 FM 2604, Whitney, Hill County, Texas 76689 and Brenda Charlene Kirkland Freeman, residing at 171 CR 1518, Morgan, Bosque County, Texas 76671.

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.

11. Decedent's Will named Applicant to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting *Letters Testamentary*, and Applicant would be entitled to such Letters.


12. Decedent's Will (paragraph VI.) grants the Independent Executor full power and

authority over Decedent's assets, including the power to sell, manage and dispose of Decedent's property.

13. Pursuant to *Texas Estates Code Section 256.052(b)*, no information required for this Application has been omitted.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that *Letters Testamentary* be issued to Applicant; and that all other orders be entered as the Court may deem proper.
