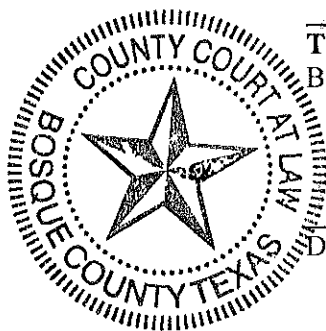

**APPLICATION FOR PROBATE OF WILL

TO THE HONORABLE JUDGE OF SAID COURT:

REBECCA JOAN MILLER and DAVID RAY MILLER, (“Applicants”) furnishes the following information to the Court for the probate of the written Will of RAY J. MILLER, A/K/A RAY JOEL MILLER (“Decedent”) and for issuance of Letters Testamentary to Applicants:

1. Applicant, REBECCA JOAN MILLER BRINKLEY is an individual interested in this Estate, domiciled in and residing at 216 CR 2137, Meridian, Texas 76665. The last three digits of Applicant’s social security number are 833.
2. Applicant, DAVID RAY MILLER, is an individual interested in this Estate, domiciled in and residing at 20329 Ralph Fair Road, Fair Oaks Ranch, Texas 78015. The last three digits of Applicant’s social security numbers are 518.

The last three digits of Decedent’s social security number are 485.
3. Decedent died on August 4, 2023 in Clifton, Bosque County, Texas, at the age of 93 years.
4. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at 167 CR 2510, Meridian, Texas on the date of his death.
5. Decedent owned real and personal property described as his home, personal effects, a motor vehicle(s) and account(s) of a probable value greater than \$75,000.00.
6. Decedent left a valid written Will (“Will”) dated March 1, 2022 which was never revoked and is filed herewith.

The subscribing witnesses to the Will and their last known addresses are Willard J. Still, 427 Woodfall Drive, Waco, Texas 76712 and Douglas J. Still, 1033 Burberry, Waco, Texas 76712. The Will is made self-proved in the manner prescribed by law.

7. No child or children were born to or adopted by Decedent after the date of the Will.
8. Decedent was never divorced after the date the Will was made.
9. A necessity exists for the administration of this estate.
10. Decedent's Will named REBECCA JOAN MILLER BRINKLEY and DAVID RAY MILLER to serve as Co-Independent Executors without bond or other security and Applicants would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Applicants would be entitled to such Letters.
11. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicants pray that citation issue as required by law to all persons in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Applicants; and that all other orders be entered as the Court may deem proper.
