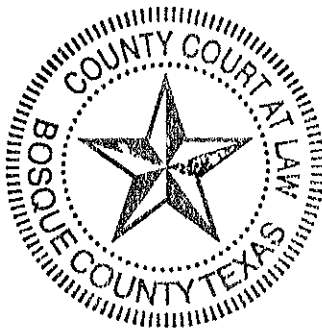

TO THE HONORABLE JUDGE OF SAID COURT:

Sharon Word (“Applicant”), furnishes the following information to the Court for the probate of the written Will and Codicil of **K.L. Word** (“Decedent”), and for issuance of Letters Testamentary to **Sharon Word**:

1. Applicant is an individual interested in this Estate, is a resident of the State of Texas, and may be served with citation at 2563 CR 2440, Iredell, Bosque County, Texas 76649.

- (a) The last three (3) numbers of Applicant’s driver’s license number are 149.
- (b) The last three (3) numbers of Applicant’s social security number are 109.

2. Decedent died on July 29, 2023, in Iredell, Bosque County, Texas, at the age of eighty-two (82) years, and four (4) years have not elapsed since the Decedent’s date of death.

- (a) The last three (3) numbers of Decedent’s driver’s license number are 535.
- (b) The last three (3) numbers of Decedent’s social security number are 818.

3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence in this County on the date of death. On the date of death, Decedent resided at 2563 CR 2440, Iredell, Bosque County, Texas 76449.

4. Decedent owned real property and personal property described generally as home, cash, securities, household goods, and personal effects with a probable value in excess of \$25,000.00.

5. Decedent left a valid written Will (“Will”) dated December 1, 2009 (“2009 Will”) and a First Codicil thereto dated July 17, 2012 (“Codicil”) (the 2009 Will and Codicil are collectively referred to herein as the “Will”), which were never revoked and are filed herewith, and there are no handwritten lists or other codicils thereto that were executed by the Decedent. At the time each of the 2009 Will and Codicil were executed, the Decedent was eighteen (18) years of age or over.


6. The subscribing witnesses to the 2009 Will are **Mikki Keller** and **Carmen Sandia**, and the subscribing witnesses to the Codicil are **Crystal Stiles** and **Audie Wienecke**. All of these witnesses were at least fourteen (14) years of age at the time the Will was executed.

7. The Will was self-proved in the manner prescribed by law.
8. No children were born to or adopted by Decedent after the date of the Will.
9. Decedent was not divorced, nor did Decedent have a marriage annulled or declared void, after the Will was executed.
10. A necessity exists for the administration of this Estate.
11. Decedent's Will named **Sharon Word** to serve without bond or other security as Independent Executor, and **Sharon Word** is not disqualified by law from serving as such or from accepting Letters Testamentary, and **Sharon Word** is entitled to such Letters. **Sharon Word** is domiciled in and resides at 2563 CR 2440, Iredell, Texas 76649 in Bosque County, Texas.
12. Neither the State, nor a governmental agency of the State, nor any charitable organization is named as a devisee under the Will.

Applicant prays that citation be issued as required by law to all persons interested in this Estate, that the Will be admitted to probate; that Letters Testamentary be issued to **Sharon Word**; and that all other orders be entered as the Court may deem proper.
