**APPLICATION FOR PROBATE OF A COPY OF WILL
AND FOR ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

THEODORE LEE GEBHARDT (“Applicant”) furnishes the following information to the Court for the probate of a Copy of the Will of KAY CLAUSS GEBHARDT (“Decedent”) and for issuance of Letters Testamentary to Applicant:

1. Applicant, THEODORE LEE GEBHARDT is an individual interested in this Estate, domiciled and residing at 127 Private Road 2500, Meridian, Texas 76665. The last three digits of, THEODORE LEE GEBHARDT’s social security number are xxx-xx-x829.
2. Decedent died on September 5, 2023, in Granbury, Hood County, Texas, at the age of 84 years. The last three digits of Decedent’s social security number are xxx-xx-x748.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at 1005 Main Street, Meridian, Texas 76665, on the date of Decedent’s death.
4. Decedent owned real and personal property described generally as a home, a vehicle, household goods, and personal effects, of a probable value in excess of \$70,000.00.
5. Decedent left a valid written Will (“Will”) dated January 12, 2011. Unfortunately, Applicant has been unable to find the original Will so a true and correct copy of same has been filed with this Application. To the best of Applicant’s knowledge, Decedent never revoked said Will.

So far as known to Applicant, the photocopy of the Will filed herewith accurately describes the contents of the original Will. Applicant further states the photocopy of the Will attached hereto also has attached to it a photocopy of the Self Proving Affidavit signed by the Decedent on the original Will.

6. The subscribing witnesses to the Will are Natalie Koehler whose present address is 401 South Hill Street, Meridian, Texas 76665 and Jennifer McNaught whose present address is 114 South Erath, Meridian, Texas 76665 and the Will is self proved.
7. No child or children were born to or adopted by Decedent after the date of the Will.

8. No marriage of the Decedent was dissolved after the date of the Will (See Section 256.052 Estates Code).
9. A necessity exists for the administration of this estate.
10. Decedent's Copy of the Will named Applicant to serve as Independent Executor without bond or other security and Applicant would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Applicant would be entitled to such Letters.
11. The names, addresses, whether the persons are adults or minors and the relationship of each person who would inherit as an heir of the testator in the absence of a valid Will are as follows:

The beneficiaries of said Will are the same persons as the heirs of the Decedent.

12. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, but did name First Presbyterian Church of Clifton, Texas and the Meridian Public Library in Meridian, Texas as devisees.

Applicant prays that citation issue as required by law to all persons in this Estate;

that the photocopy of the Will be admitted to probate; that Letters Testamentary be issued to Applicant as Independent Executrix without bond; and that all other orders be entered as the Court may deem proper.
