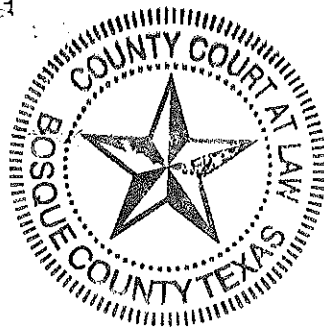

**APPLICATION FOR PROBATE OF WILL
 AND ISSUANCE OF LETTERS TESTAMENTARY**

To the Honorable Judge of the Court:

Roger W. Parks, *Applicant*, furnishes the following information to the Court for the probate of the written Will of **Charlene Williamson Parks**, *Decedent*, and for issuance of *Letters Testamentary*:

1. Applicant is an individual interested in this estate, domiciled in and residing at 184 PR 4261, Clifton, Bosque County, Texas 76634. The last three digits of Applicant's Social Security and Texas driver's license numbers are 253 and 620, respectively.

2. Decedent died on September 17, 2023, at Lutheran Sunset Home in Clifton, Bosque County, Texas 76634 at the age of 88 years. The last three digits of Decedent's Social Security number and driver's license numbers are 154 and 345, respectively.

3. This Court has jurisdiction and venue because Decedent resided in this county at the time of death and/or Decedent owned property interests in this county.

4. Decedent owned real and personal property described generally as homestead and other real estate in Bosque County, Texas, stocks, note receivable, bank accounts, vehicles, household goods and personal effects of a probable value of less than \$600,000.

5. Decedent left a valid, written Will dated September 25, 2018, *the Will*, which was never revoked and is filed in this cause.

6. The subscribing witnesses to the Will were Patricia Coy (now Ferguson), who currently resides near China Spring, Bosque County, Texas & Jessica Erickson, who

currently resides in Clifton, Bosque County, Texas. The Will was self-proved in the manner prescribed by law.

7. Decedent was married twice. Decedent's first marriage was to Tom Gilliam Parks who died in the year 1990, in Bosque County, Texas. Of this marriage, only three children were born:

Tom Gilliam Parks, Jr., now an adult, residing at 1779 CR 4240, Clifton, Bosque County, Texas 76634;

Teresa Anne Parks Ingram, now an adult, residing at 2901 Racquet Club Dr., Midland, Midland County, Texas 79705; and

Roger W. Parks, now an adult, residing at 184 PR 4261, Clifton, Bosque County, Texas 76634.

Decedent's second marriage was to Walter L. Raynaud which ended in divorce in about the year 2010. Of this marriage, no children were born.

No other child was ever born to Decedent, adopted by Decedent, or taken into Decedent's home with the understanding of adoption.

None of Decedent's marriages were dissolved after the date of the Will.

8. A necessity exists for administration of this estate.

9. Neither Texas, nor any governmental agency of Texas, nor any charitable organization is named in the Will as a devisee. The Will's beneficiaries are Tom Gilliam Parks, Jr. residing at 1779 CR 4240, Clifton, Bosque County, Texas 76634; Teresa Anne Parks Ingram residing at 2901 Racquet Club Dr., Midland, Midland County, Texas 79705 and Roger W. Parks residing at 184 PR 4261, Clifton, Bosque County, Texas 76634.

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.

11. Decedent's Will named Applicant to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting *Letters Testamentary*, and Applicant would be entitled to such Letters.

12. Decedent's Will (paragraph IX.) grants the Independent Executor full power and authority over Decedent's assets, including the power to sell, manage and dispose of Decedent's property.

13. Pursuant to *Texas Estates Code Section 256.052(b)*, no information required for this Application has been omitted.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that *Letters Testamentary* be issued to Applicant; and that all other orders be entered as the Court may deem proper.
