
Hearing on said Transferred Guardianship Application for Appointment of Permanent

The clerk may require a deposit to cover the estimated costs of furnishing you with the request notice.



ORDER TRANSFERRING GUARDIANSHIP  
TO BOSQUE COUNTY

On this day, the Court considered the Application filed by Friends for Life, Guardian herein, for the transfer of this guardianship proceeding to BOSQUE County, Texas under §§1023.003, 1023.004 and 1023.005 of the Texas Estates Code. After considering said Application along with any waivers or pleadings filed relative thereto, the Court finds that notice and citation on this Application are not necessary because the Guardian is the applicant and the sureties on the bond herein have filed waivers regarding and waiving same; that this guardianship is in good standing at the time of this transfer; that it is in the best interest of the Ward to transfer the proceeding to said county; that the Ward has resided in the county to which the guardianship is to be transferred for at least six months and that no good cause has been shown to deny this transfer; that this guardianship is presently in compliance with the Texas Estates Code, and this Application should be granted.

**IT IS THEREFORE ORDERED** that the guardian's Bond filed herein shall remain in effect until a rider or other surety has been filed in accordance with Section 1023.010 of the Texas Estates Code; the Clerk shall transmit to the county clerk of BOSQUE County the case file of the guardianship proceedings; and a certified copy of the index of the guardianship proceedings as required by Section 1023.006 of the Texas Estates Code and this proceeding shall be transferred to the Court in BOSQUE County, Texas having jurisdiction over probate matters.
