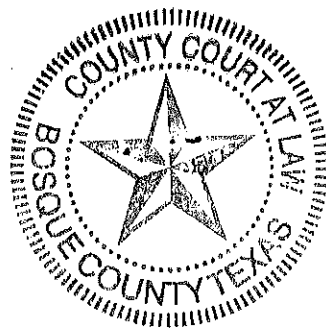

TO THE HONORABLE JUDGE OF SAID COURT:

INA RENEE HARRIOTT (“Applicant”) furnishes the following information to the Court for the probate of the written Will of JOHN RABURN FORD, (“Decedent”) and for issuance of Letters Testamentary to Applicant:


1. Applicant, INA RENEE HARRIOTT is an individual interested in this Estate, domiciled and residing at 198 CR 1291, Morgan, Texas 76671. The last three digits of, INA RENEE HARRIOTT’s social security number are xxx-xx-x863.
2. Decedent died on January 11, 2024, in Waco, McLennan County, Texas, at Baylor Scott & White Hospital at the age of 79 years. The last three digits of Decedent’s social security number are xxx-xx-x486.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at 139 CR 1241, Kopperl, Texas 76652, on the date of Decedent’s death.
4. Decedent owned real and personal property described generally as a home, a vehicle, household goods, and personal effects, of a probable value in excess of \$50,000.00.
5. Decedent left a valid written Will (“Will”) dated March 27, 2023, which was never revoked and is filed herewith.
6. The subscribing witnesses to the Will are Signi Knudson whose present address is 1194 CR 4120, Meridian, Texas 76665 and Bernadette Yant whose present address is 408 S. Somervelle, Iredell, Texas 76649 and the Will is self proved.
7. No child or children were born to or adopted by Decedent after the date of the Will.

9. No marriage of the Decedent was dissolved after the date of the Will (See Section 256.052 Estates Code).
10. A necessity exists for the administration of this estate.
11. Decedent's Will named Applicant to serve as Independent Executor without bond or other security and Applicant would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Applicant would be entitled to such Letters.
12. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Applicant as Independent Executrix without bond; and that all other orders be entered as the Court may deem proper.
