


All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.



**APPLICATION FOR PROBATE OF WILL**  
**AND FOR ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

WILLIAM CRAIG POLLARD (“Applicant”) furnishes the following information to the Court for the probate of the written Will of WILLIAM HALE POLLARD, (“Decedent”) and for issuance of Letters Testamentary to Applicant:


1. Applicant, WILLIAM CRAIG POLLARD is an individual interested in this Estate, domiciled and residing at 1302 CR 1035, Clifton, Texas 76634. The last three digits of, WILLIAM CRAIG POLLARD’s social security number are xxx-xx-x252.
2. Decedent died on December 7, 2023, in Clifton, Bosque County, Texas, at the age of 89 years. The last three digits of Decedent’s social security number are xxx-xx-x193.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at 1302 CR 1035, Clifton, Texas 76634 on the date of Decedent’s death.
4. Decedent owned real and personal property described generally as real estate, (which passed as a non probate asset under a Gift Warranty Deed Reserving Enhanced Life Estate with Power of Sale, dated July 25, 2023), a vehicle, horse trailer, tack, household goods, and personal effects, of a probable value of \$15,000.00.
5. Decedent left a valid written Will (“Will”) dated July 25, 2023, which was never revoked and is filed herewith.
6. The subscribing witnesses to the Will are Kent Bratcher whose present address is 113 W. River Street, Meridian, Texas 76665 and Susan Godwin whose present address is 115 W. River Street, Meridian, Texas 76665 and the Will is self proved.
7. No child or children were born to or adopted by Decedent after the date of the Will.

9. No marriage of the Decedent was dissolved after the date of the Will (See Section 256.052 Estates Code).
10. A necessity exists for the administration of this estate.
11. Decedent's Will named Applicant to serve as Independent Executor without bond or other security and Applicant would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Applicant would be entitled to such Letters.
12. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Applicant as Independent Executrix without bond; and that all other orders be entered as the Court may deem proper.
