APPLICATION TO DETERMINE HEIRSHIP

TO THE HONORABLE JUDGE OF SAID COURT:

The undersigned **Applicant** files this Application to Determine Heirship and Application for Independent Administration of the property and Estate of DAVID SCOTT BRUNSON, Deceased, and for Letters of Independent Administration:

1. To **Applicant's** best knowledge and belief, DAVID SCOTT BRUNSON, **Applicant's** brother, "Decedent", died without a Will.
2. **Applicant**, GARY EDWARD BRUNSON, is an individual interested in this Estate, domiciled in and residing at 11090 FM 219, Clifton, Bosque County, Texas. The last three (3) digits of the Social Security number of GARY EDWARD BRUNSON are XXX-XX-X038. The last three (3) digits of the drivers license of GARY EDWARD BRUNSON are xxxxx656.
3. **Applicant** expects that **Applicant's** brothers who are LAWRENCE KEITH BRUNSON and RICHARD SPEER BRUNSON will consent to the appointment of **Applicant** as sole Independent Administrator of the Decedent's estate without bond.
4. Decedent died on August 10, 2024, in Ukraine, Cherkasy region, Umanskyi district, village of Rodnikivka at the age of 69 years. The last three (3) digits of the Social Security number of DAVID SCOTT BRUNSON are XXX-XX-X468.
5. This Court has jurisdiction and venue over the Decedent's estate for the reason that the Decedent died outside of the United States on approximately the 10th day of August, 2024 and **Applicant** is the only nearest next of kin that lives in the state of Texas at 11090 FM 219, Cranfills Gap, Bosque County, Texas. See section 33.001(B)(i) of the Estates Code of Texas.


6. Decedent owned personal property in the United States described generally as financial investments located in financial institutions in the United States, of a probable value in excess of \$50,000.00.
7. The Decedent was never married and no children were born to or adopted by the Decedent.
8. The names, physical addresses where service can be had, the relationship of each heir to Decedent, whether each heir is a adult or minor and the true interest of the Co-Applicant and each of the heirs in the Decedent's estate are as follows:

A necessity exists for the Independent Administration of Decedent's property and Estate to consider payment of claims, and to resolve other matters which require the authorization of a personal representative in settling Decedent's estate, and to sell any property that may need to be sold or liquidated without further order of the Court.
10. **Applicant** is not disqualified by law from serving as Independent Administrator of Decedent's Estate.
11. **Applicant** requests that this Court, upon notice and hearing as required by law, appoint Applicant as Independent Administrator, without bond, and for an order authorizing him to sell property of the Estate without further Order of the Court.
12. **Applicant** also requests that no other action shall be had in this Court other than the return of an Inventory, Appraisement, and List of Claims required by law or affidavit in Lieu thereof as allowed by law and the notice to beneficiaries required by the Texas Estates Code including Section 308.002 and for such other and further orders appropriate to this Estate.

Applicant prays that citation issue as required by law to all persons in this Estate including citation upon unknown heirs; that Letters granting Independent Administration without bond be issued to **Applicant**; that the Court declare GARY EDWARD BRUNSON, LAWRENCE KEITH BRUNSON, and RICHARD SPEER BRUNSON as the only heirs of the Decedent; and that all other Orders be entered as the Court may deem proper.


