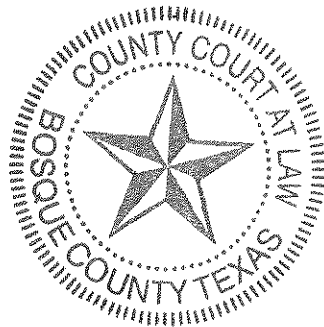

**APPLICATION FOR PROBATE OF WILL AS A MUNIMENT OF TITLE**

**Applicant: Lance Wayne Moore**

**Decedent: Al Wayne Moore**

Applicant files this application for the probate of the written Will of Decedent as a Muniment of Title, and shows the Court as follows:

*1. Applicant's Information*

Applicant, Lance Wayne Moore, a person interested in this estate, is domiciled in Dallas County, and may be served at 5445 Caruth Haven Lane #2021, Dallas, Texas 75225. The last three digits of Lance Wayne Moore's Social Security number are 925. The last three digits of Lance Wayne Moore's Texas driver's license are 037.

*2. Decedent's Information*

Decedent, Al Wayne Moore, was domiciled at 295 CR 2100, Meridian, Bosque County, Texas 76665. On the date of death, Decedent was 81 years old.

The last three digits of Decedent's Social Security number are 727. The last three digits of Decedent's Texas driver's license are 291.

*3. Fact, Date, and Place of Death*

Al Wayne Moore, Decedent, died on July 26, 2024, in Meridian, Bosque County, Texas.

4. *Jurisdiction and Venue*

This Court has jurisdiction over this matter and venue is proper because Decedent resided in this county and had a domicile or fixed place of residence in Texas.

5. *Property*

Decedent owned real and personal property having an aggregate probable value not in excess of \$500,000.00.

6. *Medicaid Benefits*

Decedent did not receive Medicaid benefits on or after March 1, 2005.

7. *Details of Will*

Decedent executed a valid, written Will on June 20, 2016, which was never revoked. The Will was made self-proved as provided by Section 251.104 of the Texas Estates Code.

8. *Subscribing Witnesses to the Will*

The subscribing witnesses to Decedent's Will are: Bernadette Yant and Signi Knudson.

9. *Executor Facts*

Decedent's Will named Lance Wayne Moore, who may be served at the address listed earlier, as executor to serve without bond or security.

10. *After-Born Children*

No children were born to or adopted by Decedent after execution of the Will.

10. *No Unsecured, Unpaid Debt*

Decedent's estate does not owe an unpaid debt, other than any debt secured by a lien on real estate, or for another reason there is no necessity for administration of the estate.

11. *Divorce After Execution of Will*

No marriage of Decedent was ever dissolved after the Will was executed by Decedent.

12. *Government Agency or Charity Named as Devisee*

Decedent's Will does not name the State of Texas, an agency of the state, or a charitable organization as a devisee.

13. *Time Between Date of Death and Application*

Four years have not elapsed since the date of Decedent's death and before the application.

14. *Relief Requested*

Applicant requests that citation issue to all persons having any interest in Decedent's estate as required by law, that Decedent's Will be admitted to probate as a muniment of title without any administration of the Will or estate required, and that this Court enter all other orders it deems proper.
