

All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.



TO THE HONORABLE JUDGE OF SAID COURT:

FRANKLIN D. HULKE ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of BILLIE R. HULKE ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, FRANKLIN D. HULKE, is an individual interested in this Estate, being domiciled in and residing in Texas. FRANKLIN D. HULKE's address for service of citation is 252 County Road 4285, Valley Mills, Texas 76689. The last three digits of the social security number of FRANKLIN D. HULKE are 604. The last three digits of the driver's license number of FRANKLIN D. HULKE are 991.

2. Decedent died on October 29, 2023, at Waco, McLennan County, Texas, at the age of 81 years. Decedent's domicile at the time of her death was Valley Mills, Bosque County, Texas. The last three digits of the social security number of Decedent are 155.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of her death.

4. Decedent owned property described generally as cash, personal effects and household goods of a probable value in excess of \$25,000.00.

5. Decedent left a valid Will dated April 29, 2016, which was never revoked.

6. A true and correct copy of the Will is attached. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

7. A necessity exists for the administration of the Estate.

8. After the date of the Will, no child was born to or adopted by Decedent.

9. No marriage of the Decedent was ever dissolved after the will was made.

10. Decedent's Will named FRANKLIN D. HULKE to serve as Independent Executor to act independently. FRANKLIN D. HULKE resides in Valley Mills, Bosque County, Texas. FRANKLIN D. HULKE has not been convicted of any felony or otherwise disqualified from serving as such or from accepting Letters Testamentary, and is entitled to such letters.

11. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

12. The Will was made self-proved in the manner prescribed by law and the subscribing witnesses to the Will are RAYMOND HOELDTKE, and C.T. COLLINS.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to FRANKLIN D. HULKE; and that all other Orders be entered as the Court may deem proper.
