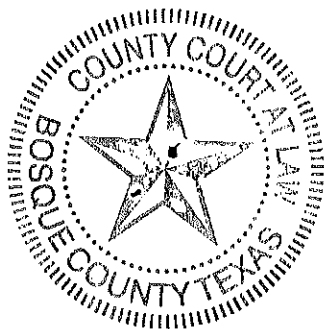


All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.



**APPLICATION FOR PROBATE OF WILL

TO THE HONORABLE JUDGE OF SAID COURT:

JUSTIN ZANE GUNTER (*“Applicant”*) furnishes the following information to the Court for the probate of the written Will of BUN V. CUMMINGS, JR. (*“Decedent”*) and for issuance of Letters Testamentary to Applicant:

1. JUSTIN ZANE GUNTER (SSN - XXX-XX-X552 and Texas DL #XXXXXX710) is an individual interested in this Estate, domiciled in and residing at 545 CR 3145, Valley Mills, Texas 76689.

2. Decedent died on September 17, 2024, in Waco, McLennan County, Texas, at the age of 73 years. The last three numbers of Decedent’s driver’s license number are 515, and the last three numbers of Decedent’s Social Security number are 562.

3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence in this County on the date of death.

4. Decedent owned real and personal property generally described as a residence, other real property, cash, securities, automobiles and personal effects of a probable value in excess of \$10,000.

5. Decedent left a valid written Will (*“Will”*) dated November 12, 2013, which was never revoked and is filed herewith.

6. The subscribing witnesses to Decedent’s Will are:

The Will was made self-proven in the manner prescribed by law.

7. No child or children were born to or adopted by Decedent after the date of the Will.

8. No marriage of Decedent was dissolved after the date of Decedent’s Will.

9. A necessity exists for the administration of this estate.

10. Decedent's Will named Justin Zane Gunter as Independent Executor to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Applicant would be entitled to such Letters.

11. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Applicant; and that all other orders be entered as the Court may deem proper.
